Re: Department of the Treasury Assassination-Related Records Located Among <u>Holdings</u> of the National Archives and Records Administration

Dear Mr. Dougherty:

In connection with our efforts to identify documents relating to the Kennedy assassination, we have discovered several assassination-related documents of the Department of the Treasury that are in the National Archives & Records Administration ("NARA"). The Assassination Records Review Board recommends that the Department of the Treasury designate these documents as assassination records and place them in the JFK Assassination Records Collection ("JFK Collection") at NARA.

These documents were located among the chronological files of Mr. G. d'Andelot Belin, who was General Counsel for the Department of the Treasury during the Warren Commission's proceedings. These files appear to contain only Mr. Belin's outgoing correspondence and memoranda. They were located in Accession No. 56-74-1 (Box 9). We have enclosed a list of these documents, as well as copies of the documents.

Under the JFK Act, the Department of the Treasury is responsible for processing these records and ensuring they are included in the JFK Collection at NARA. Although these records are now in NARA's legal custody, we learned from NARA that legal custody was obtained from Treasury in

February 1996. Since legal transfer of these records was effected after the JFK Act was passed in 1992, the Department of the Treasury remains responsible for processing the records.

Please notify the Review Board in writing when the Department of the Treasury transmits these and other assassination-related records to the JFK Collection at NARA. Thank you for your cooperation, and please do not hesitate to call me if you have any questions.
