- ARRB Executive Director, Dr. David G. Marwell, will be in London on Monday, November 4 on his return from meetings win Moscow and Minsk. Dr. Marwell would like to review the records identified in REFTEL that are located at the Public Records Office in Kew.
- 3. Given that Dr. Marwell has limited time, it would be appreciated if the Public Records Office could be contacted and requested to make arrangements that would allow Marwell to review the identified records as quickly as possible.
