Subject:	Review of FBI File's Anti-Castro Activities (FBI-26)

I have completed my review of the FBI's files (listed below) on the above-mentioned topic. The only assassination related material that I found is located in the field office files.

The files consists of information sheets (physical description, residence, education, etc.) on Cubans claiming to be political refugees, some of whom were involved in anti-Castro activities. The files also contain general surveillance of anti-Castro activities such as protest marches, efforts by Cuban exiles to procure weapons and some information on attacks on targets controlled by the Castro government.
