MD 60, page 8 (lines 3-6): Ebersole testified that one film contained no image and was destroyed.

MD 60, page 21 (lines 6-23): Ebersole testified that all 3 X-Rays of fragments were taken on a stationary machine in the main X-Ray department.

When did your official duties as an X-Ray technologist in regard to President Kennedy's autopsy come to an end? (i.e., what was the last task you performed in relation to the autopsy, and at about what time and on what date was it performed?)

MD 60, page 20 (lines 6-12): Ebersole testified that the autopsy was still going on between midnight and one o'clock during the period he was X-Raying the 3 loose fragments.

MD 60, page 52 (lines 19-23): Ebersole testified he left the morgue about 3 A.M.

Who directed you to cease work and gave you permission to go home? When?

Review of different totals in the existing documents re: number of X-Rays taken--

Show the witness, and ask for comment:

**MD 151, page 5:** S & O wrote "11 X-Rays"

MD 190: First version of 11/22/63 receipt indicated "8 plus 3" [11 total] before handwritten change modified "three" 10 X 12 inch X-Rays to "six" [new total of 14];

MD 191: "eight plus six" [total of 14];

MD 13: November 10, 1966 document shows a total of 14 X-Rays.

## Wounds as observed at Autopsy (prior to incisions or manipulations):

#### Head:

How many wounds to head?

Location?

MD 194, page 2 at top of page: Reed recalled "the first was very large and located in the right hemisphere *in the occipital region.*"

Please draw on anatomical diagram. [Mark as exhibit.]

Was any scalp missing entirely, or just torn?

General appearance of head/hair: generally clean, or matted blood (messy)?

#### Brain:

Could you see brain in the cranium through the head wound when you first observed the wound?

Did you see the pathologists remove a brain?

How much, percentage wise, of the brain was missing? What portion of the brain was missing (back,

front, one side or the other)?

Did you see the brain weighed?

#### Skull:

Did the pathologists attempt to locate the large skull fragment (brought into the morgue late in the autopsy) into the skull?

MD 60, page 5 (lines 6-9): Ebersole testified that the large fragment was occipital bone.

Do you agree with his recollection? Why?

## Body:

Did you see any other wounds aside from the head wound?

Anterior throat? Describe

Was it sutured?

MD 60, pages 3 (lines 16-17) and 9 (lines 20-23): Ebersole testified to neatly sutured transverse surgical wound on the anterior neck.

Posterior thorax? Describe location with as much precision as possible.

MD 1: Do you agree with location?

Probed with fingers or metal instruments?

Was angle of entry discussed?

Did the pathologists at the autopsy believe the bullet which entered the thorax from the rear transited the body or not?

When was this wound first noticed? (Early or late?)

## **Comments/Conclusions of Pathologists**

Do you recall any comments made by pathologists immediately after the body was unwrapped/placed on table?

Do you recall any speculations or conclusions of the pathologists?

Number of bullets which hit the body

Path of bullets (from front or rear)

Do you recall any discussions on the telephone during the autopsy between Dr. Humes and anyone in Dallas about a wound in the throat, or anything in general about "information received from Dallas"?

If so, was there any subsequent discussion of a bullet wound in the anterior throat (as opposed to a simple tracheotomy)?

Was it described as an entry or exit?

MD 60, pages 4-5, 20 (lines 13-19), and pages 51-52: Ebersole testified repeatedly that information about an exit wound in the anterior neck was received from Dallas, and that Dr. Humes had assimilated this information.

Do you recall what Dr. Ebersole recalled in his testimony?

What did you conclude yourself at the time about what had caused the President's wounds?

Did you discuss your views with anyone?

Did you ever read the official autopsy report or portions of the Warren Report?

Did you agree with the conclusions in these documents?

# **Examination of Autopsy X-Rays**

# Examine for authentication purposes

Head (#s 1-3):

A-P: was this the only A-P taken?

Large radio-opaque object: do you recall this from the night of the autopsy?

Did doctors discuss or look for this fragment of metal on the body?

#2 (Right Lateral)

Pencil-lines: did you see these the night of the autopsy? If so, who drew them and what was discussed about them? What did they represent?

Do numerous metal fragments in X-Rays 2 and 3 appear to be in the same area on the

X-Ray as they were when you saw these X-Rays at autopsy?

Do these 3 X-Rays represent the total number of head X-Rays taken at the autopsy?

Are there any missing?

Do they look the same (i.e., the damage pattern and the dark void in the anterior portion)?

Is this the type of X-Ray film you used? How can you tell (regardless of answer)?

Body (#s 7-14):

Does this number seem to represent the total number of body X-Rays taken at the autopsy?

Do the various views seem consistent with what you remember being taken, and with what you remember seeing after developing?

Can you identify which views are taken before, and after, the Y-incision?

X-Rays of Skull Fragments:

Did you see these the night of the autopsy?

If not, did you see any different X-Rays of skull fragments that night?

Who took them? Where? On what machine?

## **Autopsy Photographs**

Examine all views (including brain) for authentication purposes, and discuss in detail any perceived inconsistencies with what the witness remembers.
