I should note here that it has been a real pleasure working with Jack Tunheim. To me, he is class all the way. And in all honesty, he really is cut from the "Harshbarger cloth." He is "facts and the law" all the way and has been very impressive. I understand why you get along with him.

I have tried to follow everything that is going on in Boston be picking up the Globe and the Herald as often as possible. I really miss being a part of the office.
