T-1 is ANGEL RONALDO LUIS SALAZAR, who was interviewed at the American Embassy, Mexico, D.F., by SA RUSSELL JEAN GRAY, JR., and \_\_\_\_\_ CIA Station, Mexico, D.F. on March 4, 6 and 7, 1967.

LUIS appeared at the American Embassy to report that the Cuban intelligence service was attempting to recruit him for work in the United States. Correspondence concerning this activity is being separately submitted under his caption. LUIS is also the subject of Bufile 87-87164 and is currently on \$1000 bond awaiting trial in Miami, Florida, on an ITSP check charge.

LUIS departed Mexico for Miami on March 7, 1967, as noted in Mexico City cable dated 3/7/67 under his caption.
