COMPROMISE OF OUR SOURCE. FOR THIS REASON, THEREFORE, THE

PHOTOGRAHS CANNOT BE RELEASED AS REQUESTED IN YOUR MEMORANDUM

OF ONE FIVE MAY ONE NINE SEVEN TWO. UNQUOTE

CROPPED PHOTOS IN POSSESSION OF LEGAT, MEXICO, NOT BEING

SUBMITTED IN ABSENCE OF FURTHER INSTRUCTIONS FROM BUREAU.
