Declassify on: OADR JFK

The following information has been received from  
Ambassador Humeau, Port-au-Prince, Haiti:

"1. In view considerable attention paid in NYTimes  
Nov. 24 to Mr. and Mrs. George de Mohrenschildt, and their  
testimony before Warren Commission, Dept should have fol-  
lowing facts about their activities in Haiti.

"2. In an incident arising out of alleged custody  
of a dog, Mrs. de Mohrenschildt recently created a public  
scene in Emb reception area, pursued Emb receptionist  
(local employee) into ladies' room and slapped her.  
Mrs. de Mohrenschildt then returned later, berated Marine  
Guard, and cursed receptionist to my face. This incident  
only culmination of recent series of unpleasant episodes  
in which de Mohrenschilts involved, including attempt  
muscle in on Emb Commissary. As result, and to protect my  
staff against such arrogant and brutal treatment, I have  
told de Mohrenschildts that before they may take up any  
matter of business in Emb, they must see DCM, who will  
make necessary arrangements if business is justified.

"3. It is reliably reported to me that Mohrenschildts  
are habitually given to highly disparaging remarks against  
Americans here, American institutions and American policy.  
They are only American citizens in Haiti who are reported  
to me as voicing such views.

"4. [Even more seriously, Emb has long series of  
reports from utterly reliable [redacted] sources that Mohrenschildt  
is in frequent and close contact (several times each week) ]
