Information furnished by FRANK RITTMAYER, aka, has been made the subject of an LHM, 5 copies of which are enclosed. RITTMAYER stated that he used the alias of SHEPMAN in his letter since he had written the Bureau in 1965 requesting information concerning the FBI and was afraid that the Bureau would therefore consider him too juvenile to take his information seriously.

In view of the indefinite nature of RITTMAYER's information as well as the fact that it is hearsay several times removed and that the persons who made the statements would be extremely difficult to identify and locate, it is recommended that no further action be taken in this matter.

With regard to reBERlet *[redacted]* CIA, *[redacted]* has informed that RICHARD CASE NAGELL is well known to the Bureau and is considered to be mentally unbalanced. *(S)*
