Enclosed for the Bureau is the original and five copies of a self explanatory letterhead memorandum (LHM), regarding the interview of Richard N. Billings, conducted on 2/11/80. Also enclosed is a typewritten sheet containing the code list that Billings obtained.

Enclosed for Dallas are two copies of the same above mentioned LHM.

For Bureau information, on 2/11/80, Richard N. Billings was interviewed regarding the requested information in department memorandum to Director dated 11/21/79, under Roman Numeral Number II. In essence, Billings advised to the best of his recollection he does not recall refusing to return a handwritten code list back to Sergeant Garland Dale Fore, Madera County Sheriff's Office Chowchilla, California, that he received from him in the early part of January or February of 1979. Additionally, he does not recall making any statements that the codes were classified government codes and listed as top security. He then advised that the statements on page 7 and 8 were not accurate.
