MEXICAN AUTHORITIES HAVE INFORMED US THAT THE NICARAGUAN, ALVRADO, AFTER A LONG INTERROGATION, HAS CONFESSED IN A SIGNED STATEMENT HE DID NOT SEE OSWALD IN THE CUBAN CONSULATE HERE ON SEPTEMBER 18 OR AT ANY OTHER TIME AND THAT HE DID NOT SEE ANYONE PASS MONEY TO OSWALD. ALVARADO SAID HIS MOTIVE FOR CLAIMING THE PASSAGE OF MONEY TO OSWALD WAS TO INVOLVE THE UNITED STATES IN A WAY WHICH WOULD RESULT IN THE OVERTHROW OF CASTRO.
