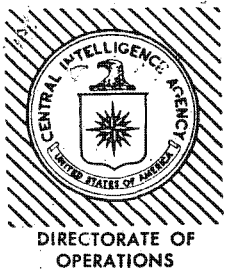

2. JUDGE WILLIAMS HAS COMMENTED THAT HE IS HAVING TROUBLE WITH THE WORDING OF HIS PORTION OF THE REPORT. HOWEVER, IT IS EXPECTED THAT THE REPORT WILL BE FINISHED SOON ALTHOUGH IT IS ALREADY TWO WEEKS LATE BEING COMPLETED. THE REPORT WILL BE PRINTED IN CANADA.

ON 4 FEBRUARY, {FNU} M O R E R O, CUBAN OFFICIAL WHO CLAIMED IN DECEMBER THAT HE WAS IN CHARGE OF MAKING A CUBAN DOCUMENTARY OF THE CRASH, SAID THAT THE CUBANS HAVE DEFINITE PROOF THAT ERIC S E A L Y, ^{Barbados} BARBADIAN CITIZEN, WAS DEEPLY INVOLVED IN THE SABOTAGE OF THE CUBANA PLANE. MORERO SAID THAT THE CUBANS HAD TURNED OVER THE EVIDENCE OF SEALY'S GUILT TO BARBADIAN OFFICIALS AND WERE WAITING TO SEE WHAT ACTION THE
