For completion of the Bureau and Miami files
in this matter concerning MANUEL RAY RIVERO and his
reported trip to Madrid, Spain, during June, 1966,
(S) [redacted] HARRY MAHONEY, who was in
San Juan during the Caribbean Games in June, 1966,
had furnished the following information:

During the Games, RAY had traveled
from San Juan to Madrid, Spain, to meet with RAFAEL
BONGO, a Cuban exile residing there whose brother
JORGE was a member of the Cuban Delegation to the
Games. CIA verified this travel of RAY. Upon his
return MAHONEY contacted RAY and requested that any
definite plans that RAY had be made known to
representatives of the United States Government
whenever they reached the formulated stage. MAHONEY
confidentially advised that CIA would have an operational
interest in RAY only if his plans became definite.
