LEGAT [SOURCES] (S) HAD REPORTED THAT BOSCH CONTENDED IGNACIO NOVO SAMPOL AND GUILLERMO NOVO SAMPOL WERE RESPONSIBLE FOR THE OPERATION AGAINST LETELIER, AND THAT THEY UNDERTOOK THE ACTION FOR CHILEAN SECRET POLICE (DINA) (S)

IN VIEW OF SENSITIVE CIRCUMSTANCES, LEGAT'S [REDACTED] [REDACTED] (S) POSITIONS TO PROVIDE ACCURATE INFORMATION IN LETELIER AND CUBANA CRASH MATTERS HAVE BEEN SOMEWHAT CURTAILED DURING THE PAST TWO WEEKS. EFFORTS WILL BE MADE AS SOON AS FELT ADVISABLE [REDACTED]
