 CLUB LOCATED ABOUT FOUR MILES EAST OF CAMAGUEY AND ONE MILE  
 NORTH OF CENTRAL HIGHWAY, AND ONLY RUSSIANS CAN ENTER THIS AREA.  
 INHABITANTS OF CAMAGUEY SUSPECT ROCKET BASE BEING CONSTRUCTED
