CONTINUING. [IN VIEW OF KNOWN CUBAN GOVERNMENT INTEREST IN
FRANK CASTRO, WE ARE CONCENTRATING OUR EFFORTS ON HIM. HIS
POSITION AS THE NUMBER TWO LEADER OF COORDINATED UNITED
REVOLUTIONARY ORGANIZATION (CORU) MAKES HIM THE PRIME
CANDIDATE. WE WILL REPORT OUR FINDINGS AS THEY DEVELOP.
