AT CUBAN CONSULATE, NYC, AND IS NEPHEW OF CUBAN CONSUL GENERAL,
WAS CONTACTED THAT DATE BY MAN IDENTIFIED ONLY AS CINTRON
PAREN PHONETIC END PAREN. CINTRON ADVISED GUILLOT THAT THERE
WAS EQUIPMENT FOR ONE THOUSAND PERSONS INCLUDING UNIFORMS,
RIFLES AND QUOTE EVERYTHING UNQUOTE AT FORTY SECOND STREET
AND EIGHTH AVE. PAREN NYC END PAREN. CINTRON STATED THIS
INFO CAME FROM SOMEONE QUOTE ON THE INSIDE UNQUOTE AND THAT
EQUIPMENT WOULD GO TO MIAMI AFTER THE WEEKEND. GUILLOT WAS
INFORMED BY CINTRON THAT QUOTE THE SECRETARY UNQUOTE WAS AT
HOTEL SAN RAFAEL PAREN LOCATED SIXTY FIVE WEST FORTY FIFTH
STREET, NYC END PAREN AND POSSIBLY IN ROOM FIVE OR FIFTY.

* MEETING HELD ON MONDAY BY THE EXECUTIVES PAREN NOT FURTHER IDENTIFIED END PAREN. CINTRON STATED MOST OF THE MEMBERS WERE NOT AWARE OF THIS INFO AND THAT IT HAD NOT BEEN PUBLICIZED. CINTRON ASKED GUILLOT IF PELEGRIN HAD ARRIVED AND GUILLOT REPLIED IN THE NEGATIVE. NOTE PELEGRIN MAY BE IDENTICAL WITH PELEGRIN GARCIA GARCIA, WHO IS ACTIVE IN PUERTO RICAN NATIONALIST MOVEMENT IN NYC. GUILLOT TOLD CINTRON THAT QUOTE OUR COMPANION ARRIVED LAST NIGHT. HE CALLED ME AT ONE UNQUOTE. GUILLOT INDICATED THAT QUOTE OUR COMPANION UNQUOTE WISHED TO CONTACT CINTRON. ~~(S)~~(u) DISCREET INQUIRIES CONDUCTED BY NYO TEN SLASH TWENTY ONE SLASH SIXTY DISCLOSED THAT ROOM FIVE C AT SAN RAFAEL HOTEL, NYC, IS UTILIZED BY MEMBERS OF SUBJECT ORGANIZATION, WHICH IS HEADED BY LUIS ERNESTO CONTE AGUERO. INQUIRIES ALSO DISCLOSED LUIS CONTE AGUERO DEPARTED NEW YORK NIGHT OF TEN SLASH TWENTY SLASH SIXTY FOR MIAMI, FLORIDA. PREVIOUS INVESTIGATION IN CAPTIONED CASE DISCLOSED CONTE AGUERO CAN BE CONTACTED AT MIAMI THROUGH TELEPHONE PL EIGHT DASH EIGHT NINE THREE THREE, LOCATED AT SEVEN NORTHEAST FORTY SEVENTH STREET, MIAMI BEACH.
