On 2/21/66,  CIA, advised the Liaison Agent of the following: On 2/11/66,  advised representatives of CIA of the following. On 1/26/66, while in Brussels, Belgium, he met a woman who called herself Lisa Armand. She advised  that she was there for talks with Jacques Grippa, who is the leader of the pro Chinese faction of the Belgian Communist Party, concerning the defense for William Epton. Following  conversation with Armand, he checked the hotel register where she was staying and determined that this woman's passport identification listed her as one Mrs. Frank.  advised he was furnishing this information to the Liaison Agent inasmuch as Mrs. Frank could possibly be identical with Susan Heiligman Frank, who is pro Chinese and of interest to the Bureau. (S)
