ANTI-FIDEL CASTRO ACTIVITIES, IS DASH CUBA. MIAMI ATTORNEY
O. B. CLINE, FORMER AUSA, MIAMI, CONFIDENTIALLY ADVISED THAT
APPROXIMATELY THREE FIFTEEN P. M. TODAY, JOSE RAMOS, CUBAN
VICE CONSUL ACTING IN CHARGE CUBAN CONSULATE, MIAMI,
TELEPHONED HIM LONG DISTANCE FROM HAVANA, STATING THAT CUBAN
GOVERNMENT WANTS TO FILE EXTRADITION PROCEEDINGS IMMEDIATELY
AGAINST A CUBAN EXILE IN MIAMI. RAMOS DECLINED TO FURNISH

PROCEEDINGS AND HE DESIRES CLINE TO FILE TONIGHT BEFORE U. S.
DISTRICT JUDGE. CLINE EXPECTS THAT SUBJECT OF EXTRADITION
PROCEEDINGS WILL BE PEDRO LUIS DIAZ LANZ DUE TO GREAT
IMPORTANCE WHICH CUBAN GOVERNMENT IS ATTACHING TO THIS
