As stated in Madrid letter of 5-10-62,
pertinent information regarding subject was furnished

[redacted] (u)

Reference Miami letter to the Bureau reflects
that subject proceeded to Mexico prior to the time
Russian official MIKOYAN arrived in Mexico from Cuba
and was in contact with [redacted] who Miami informant [S]
stated was reported to work for the U. S. Embassy in
Mexico City. It is the recollection of Legat, Madrid,
that [redacted] assigned to the
American Embassy in Mexico and handled [redacted] (u)

It would appear [that CIA] is completely aware
of subject's activities and possible intentions to defect (u)

In view of the above, no further action appears
necessary by the Madrid Office, and this matter is con-
sidered RUC. (u)
