6. IN REQUESTING HIS MEETING WITH LEIGH, RIVAS ASKED THAT HIS PRESENCE IN CHILE NOT BE MADE A MATTER OF PUBLIC KNOWLEDGE. FOR THIS REASON, THE MEETING WAS ARRANGED TO TAKE PLACE IN THE MINISTRY OF DEFENSE RATHER THAN AT DIEGO PORTALES GOVERNMENT HOUSE, WHERE THERE IS A GREATER RISK OF DISCOVERY BY REPORTERS.

7. (HEADQUARTERS COMMENT: A REPRESENTATIVE OF THIS AGENCY

[REDACTED] COMMENTED THAT ALTHOUGH RIVAS HAS, ON OCCASION, HANDLED (S) SPECIAL ASSIGNMENTS FOR THE PEREZ ADMINISTRATION, SUCH AN ASSIGNMENT AS DESCRIBED IN THIS REPORT IS UNUSUAL. IT IS OUT OF CHARACTER FOR PEREZ TO EXPLAIN OR APOLOGIZE FOR HIS ACTIONS AND IT APPEARS STRANGE THAT A PEREZ REPRESENTATIVE WOULD ADMIT THAT BOSCH HAS POWERFUL FRIENDS IN THE VENEZUELAN GOVERNMENT WHEN THE GOVERNMENT HAS GONE TO GREAT LENGTHS TO ATTEMPT TO HIDE THIS FACT.)
