For the information of the Bureau, Miami and San Juan, Mexico City has received no information from Embassy or local sources in Nicaragua confirming the training of mercenaries in Nicaragua.

While Mexico City doubts seriously that anywhere near 22,000 mercenaries could be training in Nicaragua without the knowledge of this office's sources, inquiry will be made regarding this matter with the Defense Attache Embassy officials and local contacts during the September, 1970, road trip to Nicaragua.
