Re Mexico City letter dated 12/12/74 and Miami letter dated 12/12/74.

Sgt. JORGE LATINEZ (NA) (protect), Panamanian Intelligence Service, Panama City, Panama, on 2/27/75 advised that he had no information concerning a RAY NUNEZ who is reportedly employed by captioned subject as a photographer. Source further indicated that he has no information indicating that subject has been in Panama recently for the purpose of interviewing high officials of the Panamanian government.

Checks made through the files of the Consular Section, Political Section and   at the U. S. Embassy in Panama on 2/28/75 met with negative results.

No further action is being taken at Panama in the absence of any additional specific leads.
