an LHM dated and captioned as above.

One copy of this LHM is being furnished
locally to INS and CIA, which agencies have a continuing
interest in subject's activities. *J (u)*

As previously noted, PEREZ was subject of some
inquiry in connection with a case captioned, "UNKNOWN
SUBJECTS; BOMB EXPLOSION IN FRONT OF THE CUBAN EMBASSY,
PARIS, FRANCE, JULY 3, 1974, IS-CUBA". Interviews
with PEREZ' relatives in San Juan as contained in this
LHM were furnished by San Juan by letter dated 10/24/74,
in the bombing *file*.

On 8/8/74, CIA COVERT *(protect)* advised
that DUNNEY PEREZ was recruited in 12/65 for use by CIA
as a recruiter. He received agent and team training which
included demolition training. He was terminated by CIA
12/31/66 due to his inability to establish location and
operational conditions for the agency. CIA had no
current information re PEREZ (confidential).
