ACTIVITIES IN FLORIDA, FROM ARMANDO SOSA RODRIGUEZ, WHO HAS
EXCELLENT CONTACTS IN POLITICAL AND MILITANT GROUPS IN THE MIAMI
EXILE COMMUNITY.

1. AS OF 14 JUNE 1963 THE COMANDOS LIBRES GROUP HEADED BY
ANTONIO CUESTA DEL VALLE WAS RUMORED TO BE PLANNING A RAID
AGAINST THE NORTHERN COAST OF CUBA, WHICH IS TO TAKE PLACE
BETWEEN 15 AND 20 JUNE 1963. THE TARGET AREA WAS SAID TO BE
SOMEWHERE CLOSE TO THE BOUNDARY LINE BETWEEN MATANZAS AND HABANA
PROVINCES.

2. FIELD COMMENT: TDCSDB-3/654,374, DATED 27 APRIL 1963,
REPORTED THAT COMANDOS-L (COMANDOS LIBRES) WAS PLANNING A RAID
AFTER THE WEEKEND OF 28 APRIL. TDCSDB-3/654,384, DATED 28 APRIL
1963, REPORTED THAT AS OF 27 APRIL THE PLANS FOR THE RAID HAD
