Reference is made to the letter from this Bureau dated April 11, 1962.

On April 16, 1962, Martha Aguiar, who is mentioned in referenced letter, telephonically contacted our New York Office and advised that on April 15, 1962, she received a cable from Havana, Cuba, from Jose Manuel Martinez Sierra. According to Aguiar, the cable indicated that he wanted to thank those concerned because he had just received all necessary documents, including the desired "waiver visas" and the postal money orders, needed for Martinez and his family to leave Cuba. Aguiar stated that Martinez and she would be forever grateful for what had been done for Martinez and his family.
