Mrs. Jane Roman, Central Intelligence Agency (CIA), telephonically advised on 2-18-60 that the following information was received by cable of the same date from Rio de Janeiro. (S)

Brazilian officials reported that three men are in Miami, Florida, attempting to charter a plane for the purpose of carrying arms to an unknown destination in Brazil. These arms are to be used for "an unknown Cuban enterprise." The individuals involved are using the names as captioned above. One of them is wearing a Brazilian Army uniform. Brazilians are attempting to obtain additional details. CIA is trying to obtain the identity of the Brazilian source and will keep us advised. CIA has furnished this information to Customs, Immigration and Naturalization Service and Secret Service. (S) (u)
