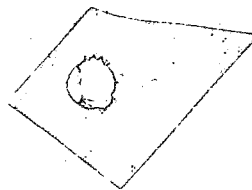

SUBJECT: FRANCISCO QUINTANA ULACIA  
INTERNAL SECURITY - CUBA

The Bureau developed information suggesting the possibility that the captioned individual might be identical with "Paco," who allegedly is working in behalf of the Castro Government. "Paco's" whereabouts is unknown, but our information indicated that he might be connected with CLIP, the sensitive CIA project. All pertinent information developed by us has been disseminated to CIA. *(S) (u)*

On December 1, 1960, [redacted] *(S)* CIA, advised the Liaison Agent that subject is definitely of operational interest to CIA and at the present time is outside of the U. S. [redacted] *(S)* stated that CIA has taken steps to determine if the subject is identical with "Paco." CIA does not possess any derogatory information concerning subject *(S)*
