SUBJECT: Edgar SILVESTRE Reyes

1. This Agency requests any information that the Bureau may have on Edgar SILVESTRE Reyes, who was born in Cabo Rojo, Puerto Rico, on 8 November 1931, son of Carmelo and Carmen who is married and an American citizen. He studied medicine at the University of Valladolid, Spain, and lived in Valladolid on Calle de la Pasion 4. We have a report that Subject left Spain on 4 October 1960 and is presently a Communist leader in either Cuba or Venezuela. He reportedly has the position of chief instigator of the Communist party in these countries.

2. This Agency would appreciate it if the Bureau would identify those portions of any information on Edgar SILVESTRE Reyes
