CIA has advised it is currently conducting a program designed to come up with [redacted] in Cuba who possibly could be [redacted]. The subject, who is considered by CIA to be an important communist party official in Cuba at the present time, has been selected as [redacted]. In this connection CIA is contemplating approaching relatives of the subject who reside in the United States for the purpose of developing information concerning the subject. CIA advised that contact with the subject might be established by use of one of the subject's relatives. CIA is being advised the Bureau has no objection to these contemplated contacts.

CIA identified the subject's relatives as follows:

Dr. Ansury Sabino Escalona Almeida, subject's brother, 130 South Oak Park Street, Oak Park, Illinois. Chicago File 105-8774.

Fabio Escalona Almeida, brother of subject, residing at San Ignacio, Puerto Rico.

Laureano Escalona Almeida, brother of subject, whereabouts unknown.
