1. [redacted] (S) has requested this agency for information on Armada BECEA (DPOB: 15 August 1917 in Albania), bearer of U. S. Passport No. 2427216, issued 10 August 1960. [redacted] (S) claims that Subject was recently in touch with persons suspected of collaborating with the Albanian Intelligence Service, with no further details given. [redacted] (S) did not indicate whether Subject (S) contacted the suspects in Italy or elsewhere. [redacted] (S) has been asked to supply more details; their reply will be transmitted to you when received.

2. We will appreciate your supplying us with any vital data and/or identifiable demographic information on Subject which can be passed to [redacted] (S). This Agency has no other information on Subject.
