On S 10/8/63, Mrs. Anita Potocki, a CIA analyst who has been working on Dadvised the Liaison Agent that her Agency has come to the tentative conclu-sion that Pineirol's identical with Petronio, Swho has been men-tioned in messages made available to the Bureau and CIA. We have noted that messages sent to the unidentified Cuban Agent in Panama referred to as ["Roberto"] have been signed by ["Petronio]" Mrs. Potocki gave the following explanation which led to CIA's deduction. (S)(u)Messages emanating from Havana indicated that one of the recipients was probably located in a small town in Colombia near the Venezuelan Border. CIA developed a suspect and instituted coverage. Recently, this individual transmitted a letter to Havana which communication was intercepted by CIA.. The person had apparently violated instructions by including some sensitive data in the communication. Havana then transmitted a radio message beastigating the <u>Guban</u> Agent in Colombia. An examination of the radio message and the intercepted communication sent by the Agent has led CIA to believe that ("Petronio" is identical with Pineiro.
