Reference is made to memorandum dated July 10, 1961, from Mr. D. E. Moore to Mr. Sullivan. We previously had made available to Central Intelligence Agency (CIA) information concerning the subject, who offered excellent potential as a source for CIA in its foreign operations. CIA established contact with and allegedly made certain commitments to him but subject has complained that there has not been any followup action on the part of CIA. (S)

Pursuant to instructions, the Liaison Agent informed Mrs. Jane Roman, CIA, on July 13, 1961, that has become very disturbed because he has not been contacted by the Agency. It was emphasized to Mrs. Roman that certain commitments allegedly had been made to and he is waiting for action. (S)

Mrs. Roman conferred with other CIA representatives and advised that the Agency had not been able to arrange the proper type of assignment for but definitely was very much interested in him. She further stated that a CIA official would be contacting in the very near future. (S)

Based upon his discussions at CIA, the Liaison Agent received the impression that this matter is being very poorly handled by the Agency. It has an excellent opportunity to acquire the services of an unusual source but certainly does not appear to be giving this the proper type of attention. Even if the Agency did not have an assignment arranged for CIA at least could be maintaining contact with him so that his attitude would continue to be friendly and cooperative. (S) *ab*
