

Request for Studies from the CIA Historical

Offices -- the May 8 Washington Post article.

In today's Washington Post there is a story concerning the Committee's requests for documentation, which includes the charge that the staff, in asking for studies from the IA historical office, had "asked only for reports of operations that originated in either the Eisenhower or Nixon administrations." This is clearly and demonstrably not the case. I attach a copy of the 15 studies we put on our priority list. Furthermore, using a rough breakdown into categories of the some 50 studies we have requested shows the following pattern:

- (1) Studies dealing with the Kennedy/Johnson era -- 11
- (2) Studies dealing with the Eisenhower/Nixon period 4
- (3) Studies covering the period roughly 1950 through 1965 ----18
- (4) Histories prior to 1952 -- 4
- (5) Organizational histories (Office of Training, etc.) 10
- (6) No dates given on the study 1
