Dear Mr. Maheu:

Reference is made to the letter of agreement between you, representing Robert A. Maheu Associates and the Central Intelligence Agency, effective 1 August 1968.

Effective 1 September 1969 paragraphs one (1) and two (2) of said letter of agreement are deleted in their entirety and the following paragraphs are substituted in lieu thereof:

1. You will agree that [] [] employee will continue as your representative in []. In support of this arrangement, [] will pay the Firm an annual fixed fee of \$14,500 which will cover the following costs:

(a) Salary	@ \$1,000 per mo.	\$12,000.00
(b) Entertainment		600.00
(c) Travel - Local		600.00
(d) Travel - Stateside		750.00
(e) Local office expenses, phone, telegrams & postage		150.00
(f) FICA (Employers share)		400.00
TOTAL		\$14,500.00

It is agreed that prior CIA approval is required for the rental of office space and hiring of employees in support of the [] employee while in []. Also, costs incurred at the direction of and for the sole benefit of the Firm are not to be reimbursed.

2. CIA will fulfill its financial obligations by advancing funds, through a mutually agreed upon [] to your firm in equal semi-annual installments of \$7,250.00 each. Accounting for these funds will be satisfied by a signed billing from your firm stating that the funds (\$7,250.00) have been expended for services rendered. The [] employee's expenses will be monitored and in the event they deviate substantially from the above fixed amounts this agreement will again be amended and adjustments made accordingly.
