



The business about the assassination of Castro, I have read about this in the papers. I'have heard about it from associates. It has been kicked around whether this was a viable proposition or not. I have no doubt it was written into various plans as one of many options but I don't recall any successful effort that was made in this direction and since Castro is alive and apparently well in Havana, the extent to which this was serious I have never ascertained. Q Do you recall the fact that poison pills were developed to be delivered to assets or to people in Cuba for possible insertion in food or drink to be eaten by Castro?

A Were poison pills taken to Cuba? I never knew anything about this. I don't recall ever having heard anything about poison pills or any of that. What I want to say in this connection is the fact that I never heard about this doesn't mean that there were ma-y, many ideas discussed in the Agency about what to do with the Cuban Government but I don't recall anything like poison pills.


