Q: [Frank Estacione] Variety of support work; chauffeured Scott around; had 5's full confidence.  
 - Unilateral [tel. tap] operations  
 - Can't give full details; somewhat compartmentalized

Rumors to effect that HQS had located photo of LHO

Q: Doesn't recall; doesn't recall receiving photo;  
 There is a photo in LHO's M.I. file rec'd from Navy on 11/23.

Q: No penny business w/ respect to this case.  
 N. Scott wanted us to do thorough job & we did. Same w/ HQS.  
 Did a full, honest, thorough job.

Q: Not surprising that HQS didn't send photo - wasn't important enough.

Q: Lark believes that it is absolutely unlikely that LHO had a professional connection w/ Kostikov because of nature of contact.

E. Howard Hunt: no

Maurice Bishop: no

M.6. LHO as intell. agent?

Q: At minimum, there would have been a 201 file.

Q: 10/11 cable gives a 201 #

Q: N. Scott would have gotten info. particularly due to his relationship (close friends) w/ Angleton.

Q: Doesn't know why 10/10 cable to MC would have gone thru Kares messails.  
 Thinks it was unusual for that time period.
