found an FBI letterhead memo dated 18 Jan 1961 captioned "Manuel Antonio Varona, Internal Security - Cuba" contains info furnished to the FBI by a "representative of an agency of the U.S. government." Info:

A Washington businessman called on me and expressed great concern about the relationships of one of the reputed anti-Castro group leaders with representatives of the so-called International Crime Syndicate. His observations were:

- 1- V has hired Edward K. Moss as his assistant for raising funds to finance operations against Cuba.
- 2- Julia Cellini is alleged to be Moss' mistress - operates a secretarial service at 1025 Conn Ave N.W. alleged to really be a front for Edward K. Moss activities.
- 3- Julia's father alleged to have been one of big numbers racketeers
- 4- Julia's brother - Dino Cellini & his brother are active fronts for 2 of largest casinos in Cuba during Batista Regime.
- 5- Alleged that Cellini brothers are in close contact @ Varona through Moss & have offered to contribute considerable sums of money (reported as high as 2 million dollars) through Moss to Varona to

Edward Groffredo Cellini & Groffredo Cellini (Dino's brother) were known to be Evening Manager and Afternoon Manager, respectively, at the Casino International in Havana, Cuba. Dino was employed at Tropicana & Rivera → Haiti → 1961 - Miami

Dino Cellini's 201-885706 DOB 19 Nov 1914. File opened in 1971 when Dino was living in Rome.

Dino Cellini was detained in May 1959 in Havana by Cuban authorities at the request of US Bureau of Narcotics. Released June 1959 for lack of evidence.
