the insurgency & sabotage system in Cuba

-went to Havana; Morgan met him at airport & prevented his  
going thru Customs. he was told that he should make plans to  
kidnap Cuban Pres & kill Castro. \$35,000 for job.

-Jose Prendes Herrera also went to Cuba late 1960

-captured - Gentile sentenced to 30 yrs in prison in Jan 1961  
incarcerated - Isle of Pines.

-said Jack Orrisa was a comm. agent of Castro.

-He said there were 12 US citizens in jail @ time who were  
not all released, but he didn't mention their names.

2- WAVE 3608 - 13 Feb 1961 - Source [AMOT-2] reported Cellini worked at the casinos Tropicana & Riviera in Cuba before going to Haiti. Subject now residing in 12459 Key Stone Road, North Miami, Florida.

3- reported - 18 Jan 1966 that Cellini is a well known Wash D.C. gambler - ~~also~~ and "is or was a close friend of D.C. " Joseph Francis Nestini.
