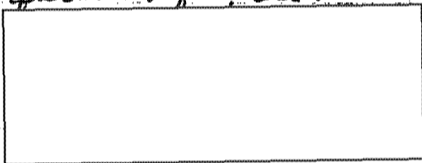

William C. Bishop, Purported Employment with CIA

1. Police Detective, Carl D. Hughes of the Mesquite, Texas, Police Department, Telephone (214) 285-6336, called to ask if the Dallas RA had any knowledge of William C. Bishop. According to Detective Hughes the Police Dispatch in Mesquite has been getting a lot of crank phone calls from an individual they believe may be Bishop. The calls concern Cuba, atomic bombs and planned assassinations.

2. Detective Hughes has talked to Bishop who will not admit to making the calls but ^{claims} to have worked for the CIA at one time and to have made a number of trips to Cuba. Bishop appears to have a background in weapons and explosives. He will not discuss his purported CIA connection with Detective Hughes saying that this must be kept secret.

3. Detective Hughes describe Bishop as a white male, born 18 Feb 1923, who lives at 3020 Walnut Street, Apt. 104, Garland, Texas. Bishop is presently employed at the Silver Leaves Nursing Home in Garland, Texas. Detective Hughes say that Bishop has been bad about the Agency, and although Bishop appears to be somewhat mentally deranged Hughes feels something should be done about him. Detective Hughes would like to be in a position to bring pressure on Bishop to shut him up and ~~was~~ would like if we could confirm or deny Bishop's CIA employment.

4. Detective Hughes is a friend of Ray Heron, a former Dallas Police Officer who worked for the Agency a short time in SOP and who also knows Bishop and feels that he is damaging the reputation of the Agency.
