At the request of Inspector Tom Kelly of the Secret Service, the files of this Bureau were reviewed for pertinent information concerning the captioned individuals in connection with their efforts to contact Mrs. Lee Oswald.

U.S. *USSR* *Europe*
David Fitch is believed to be identical with David J. Fitch, an employee of the Peace Corps. Enclosed herewith is one copy of a memorandum dated July 19, 1963 concerning David J. Fitch. In this connection, Mr. Fitch by letter dated February 6, 1963, advised that he was contemplating a trip during the Summer of 1963 to Europe and the Soviet Union and in connection therewith would be contacting offices of the Soviet Government. By letter dated September 25, 1963, Mr. Fitch advised this Bureau that he did visit the Soviet Union from July 14 to July 26, 1963. Our files also reveal that Mr. Fitch advised the Peace Corps concerning his trip to the Soviet Union. (105-124423)

With regard to Mrs. Katia Jacobs, she appears to be the spouse of John Kadzie Jacobs. With regard to Mr. Jacobs, there is enclosed herewith one copy each of five reports containing the results of an applicant-type investigation conducted by this Bureau of Mr. Jacobs in 1948. Also enclosed is one copy each of four memoranda revealing additional information concerning him. Our files contain no additional pertinent information concerning Mr. Jacobs or his family.
