By cover airtel dated January 23, 1964, the Bureau furnished a copy of a letter from the Internal Security Division of the Department, advising that during a conference on January 6, 1964, between representatives of the Foreign Agents Registration Section and representatives of Army Intelligence on matters relating to the SNFE, it was learned that Army Intelligence then had under consideration a plan which was pending final approval by a high level Department of Defense authority to use

[REDACTED], as sources for the collection of intelligence. The Army Intelligence representative advised that [REDACTED] was then a "registered Army source" in the Intelligence Source Registry maintained by CIA. The letter further advised that on January 13, 1964, Army Intelligence notified the Department that their plan had been approved, and that Army Intelligence would be using [REDACTED]

Sources

[REDACTED] for intelligence purposes. The Department stated that in view of this, they did not plan to convene a grand jury regarding the non-compliance of the SNFE to register.

The Bureau cover airtel stated that in view of Army's interest in the officials mentioned and in view of the Department's position concerning grand jury action at this time, activities of the SNFE should be followed through sources and informants.
