[REDACTED] Ambassador to U.S. advised his country 8/26/60 Senator John Kennedy delivered speech to Zionists Congress re resolution Arab-Israeli dispute. [REDACTED] Ambassador stated speech contained fallacies and exaggerated statements and promises. [REDACTED] Ambassador subsequently contacted by Senator J. W. Fulbright, Chairman, Foreign Relations Committee, who apologized for Kennedy's speech and explained it was dictated by political expediency. *(TS)*

On 9/22/60, National Security Agency furnished an intercept of [REDACTED] traffic from [REDACTED] dated 8/26/60, classified "Top Secret Daunt" as it relates to communications intelligence. *(TS)*

According to the intercept, [REDACTED] Ambassador claimed Senator Fulbright stated Kennedy's speech was not an expression of what could be considered policy of Democratic administration with Kennedy as President. *(TS)*

[REDACTED] Ambassador reportedly advised Senator Fulbright of [REDACTED] Ambassador's official displeasure with Senator Kennedy's speech as it was replete with fallacies and bias and disparagements regarding [REDACTED] rights and disregarded [REDACTED] feelings, thus indicating Senator Kennedy places personal interest before justice and interests of U.S. Senator Fulbright was advised continued efforts to obtain Jewish votes at expense of Arabs will have serious consequences, and [REDACTED] Ambassador expected Senator Fulbright to exert efforts to end such activities. Senator Fulbright stated he would attempt to comply with this request. *(TS)*

[REDACTED] Ambassador advised his superiors Senator Fulbright contacted him probably after consulting with Senator Kennedy whose speech was motivated by Senator Kennedy's desire to obtain Jewish, Catholic, and Negro minority votes in order to compensate for his loss of votes among Protestant majority which opposes Kennedy because of his Catholicism. The Ambassador was
