 IMMUNITY GRANTED TO HIM HE WOULD FACE CONTEMPT CHARGE RATHER
 THAN ANSWER. SNYDER ADVISED FEARFUL OF LIFE SHOULD HE TESTIFY
 AGAINST HOODLUMS CONNECTED WITH PROCEEDINGS.

HIGHLY CONFIDENTIAL SOURCE ADVISED TODAY JOHN D'ARCO
 CONCERNED OVER NOT HAVING RECEIVED GOVERNMENT SUBPOENA TO

 TO MAYOR DALEY AND HAVE HIM FIND OUT IF SUBPOENA OUTSTANDING
 FOR D'ARCO AND IF SO WHY NOT SERVED. SECONDLY, TO APPEAR
 WITHOUT SUBPOENA BEFORE FGJ ON MAY 21 NEXT. CHICAGO SOURCES
 CONTINUE TO ADVISE HOODLUMS NOT AWARE TO DATE/PURPOSE OF
 GOVERNMENT, THESE PROCEEDINGS.
