On September 10, 1969, Mr. STILES BOURROUGHS (protect), Commercial Department, Southern Bell Telephone and Telegraph Company, Atlanta, Georgia, advised IC MARIONNW.DAVIS of information pertaining to local Atlanta area telephone numbers.

On September 19, 1969, LOIS OGLESBY (protect), Southeastern Telephone Company, Fort Walton Beach, Florida, is the individual who furnished the information concerning the fact that telephone number 243-8770, a non-published number, is listed to C. J. CERAVOLO, 104 Fourth Street N.W., Fort Walton Beach, Florida.

Information obtained from South Central Bell Telephone and Telegraph Company on September 23, 1969, was made available by Mr. M. T. GUIROVICH, Business Manager, Lafayette, Louisiana.

On October 3, 1969, NO 1635-R (PROB), advised SA NATHAN O. BROWN that JUNIOR PROVENZANO has recently purchased a stable known as "Pretty Oaks" which is located under the Huey P. Long Bridge near Bridge City, Louisiana. Source stated that PROVENZANO paid \$12,000.00 for the buildings and is leasing the land to the railroad.

Source stated he does not know why PROVENZANO put this money into the stable as it does not appear likely to bring a decent return for his investment, noting that PROVENZANO spent every afternoon at the stable.

Source stated that he spoke with PROVENZANO during the last week of September, 1969, at which time PROVENZANO commented that the Feds had him completely tied up on a jewelry deal and, therefore, had greatly restricted his activity, but he did not elaborate further.

PCI [REDACTED] advised SA BENJAMINE F. GRAVES on August 8, 1969, that she had not seen DONALD LESTER JAMES or any of his associates at the lounge in the Admiral Benbow Motel which is located on U.S. Highway 90 in Biloxi, Mississippi, during the past few weeks.

She stated that the motel is under new management and the new manager does not welcome people like JAMES and his associates and this may be the reason that JAMES no longer frequents this motel.

PCI [ ] advised SA EDGAR L. O'NEILL, JR. on August 31, 1969, that he had heard that DONALD LESTER JAMES had been talking about leaving the Gulf Coast because the local law enforcement officers are showing too much attention to his activities. Informant stated that JAMES had mentioned selling his home in Biloxi and moving out of the area, possibly to Jackson, Mississippi.
