Recent adverse publicity concerning IRWIN WEINER and LARRY ROSENBERG regarding ALDERISIO's activities caused ALDERISIO to consider severing relationships with above who have been operating ALDERISIO's numerous legitimate enterprises. CG 6588-PC being considered by ALDERISIO as replacement for ROSENBERG and WEINER. This could result in a major breakthrough in investigation of syndicate activities. JIMMY ALLEGRETTI advised CG 6588-PC that all branches of federal government working against syndicate pointing out recent fast action of Supreme Court in GIANCANA matter was "a world's record".
