JOHN CESAR GROSSI on 4/7/70 requested a private interview and **afforded** his rights in a Waiver of Rights form, he was interviewed by SA EDGAR O. INGALLS, JR., Deming, New Mexico, at which time he gave information concerning his activities as an informant for the Buffalo, New York, field office. At the termination of the interview he alluded to but never directly asked that he be given consideration in this present problem in exchange for working undercover in the areas described in the interview for the Bureau.

On 4/10/70 information was telephonically received from the <u>Buffalo</u> Office of the FBI that JOHN CESAR <u>GROSSI</u> was a former PCI of that Office, although that office did not receive much information from him.

GROSSI was last contacted 3/69 and the case was closed on 12/23/69 in the Buffalo Office in view of the lack of contact.

On 4/14/70 JOHN CESAR GROSSI, aka Jack L. Bowen, contacted the Albuquerque Office of the FBI and requested to see an Agent at the Montessa Park Detention Center.

On 4/15/70 SA PHILLIP C. SNYDER and SA ALVIN E. HODGE interviewed GROSSI, aka Bowen, who stated that he had information about criminal activities in "Buffalo and Tucson." GROSSI was advised that we would be glad to receive any

information he had but that it would not influence his pending prosecution on an ITSMV charge. GROSSI stated that "If that is the attitude of the Albuquerque Office, I won't tell you anything."

The interview was terminated at this point.
