CRIME CONDITIONS IN JEFFERSON PARISH, LOUISIANA

In the early morning hours of 1/28/64 in the parking lot of the Old Southport Club, JAMES W. BORDELON, and FRANK PALMISANO, parking lot attendants, were wounded by unknown individuals. Investigation by the Jefferson Parish Sheriff's Office has developed that two juveniles named ROBERT E. ~~COOLEY~~ and PHILIP ~~ABRAMS~~, ages 16 and 17, were involved in a shooting affray in the New Orleans French Quarter and a robbery of a New Orleans taxi cab driver, the same night, and these individuals are suspected of being the individuals who wounded BORDELON and PALMISANO.

Captain RICHARD MORRIS, Jefferson Parish Sheriff's Office, on 2/5/64 advised that little or no information has been received from the operators of the Old Southport Club as to the identity of the individuals who shot the parking lot attendants.

NO 1205-C advised that prior to the shooting two individuals were refused admission to the Old Southport Club and when the individuals left the club they first attempted to run over SAL BOEMIA with their automobile and then became involved in the shooting affray.

NO 1205-C advised that the Old Southport Club has been closed since 1/28/64 and generally speaking gambling of the casino type is closed in Jefferson Parish. NO 1205-C advised that a newspaper article on 2/6/64 indicated that a blackjack game was located at the Cotton Club, however, NO 1205-C stated that this is not correct as there was no gambling at the Cotton Club.
