JAMES G. BRUNO, close associate of subject's brother SAM TRAFFICANTE, and JOE R. DIEZ, nothing was mentioned of subject, and he presumes subject remains in Miami.

store two weeks ago, at which time REGAN was driving a 1963 black Cadillac El Dorado, Florida license 28WW, last digits unknown, and desired two new tires for the Cadillac, stating that the car belonged to TRAFFICANTE and was being prepared for his trip to Miami where TRAFFICANTE was to meet a hoodlum named FNU SAUER (phonetic), on 4/15/63, place unknown. Source stated the name of SAUER was connected with RONNY PAGEANT (phonetic) an alleged hoodlum, out of Cincinnati, Ohio, who was formerly from Denver, Colorado.

This source also stated that the TRAFFICANTE group in Mlami hung around the Paladium as well as the race track. (Paladium not further identified).
