WEEKLY SUMMARY

Daily spot checks, subject's residence, 2505 Bristol Ave., Tampa, Fla., 5/10,13-16/63 negative for his presence.

Telephone toll calls previously set out to Bushnell and Leesburg, Fla. identified as to liquor store establishments and therefore considered in connection with AUGUST PANTELLO's business as whiskey salesman.

[Redacted] PCI(Protect), advised 5/10/63 that he is operating numerous bars and lounges in the Greater Tampa area and his sources indicate subject spends all his time in Miami, with frequent visits to Tampa, and that subject along with his brothers have no more political influence in the Greater Tampa area and are going broke. Source advised numbers activity only handled by Negroes and Cubans and it is very poor business.

HERB GOLDBURG, next door neighbor of subject's Tampa residence, advised neither subject nor wife have been seen by his family.

On 5/13/63, JOE MORTELLARO CACCIATORE, uncle of subject, advised he has not seen subject in many months, but that over the previous week-end he had seen his sisters, Mrs. SANTO TRAFFICANTE, SR., Mrs. ROSE LONGO and another sister who is mother of ARMANDO RIOS, and he understands that HENRY, FANO, FRANK and SAM TRAFFICANTE were all in very poor financial position. He also said he understands from the above persons that SANTO spends most all of his time in Miami.

On the early morning of 5/13/63 and on the evening of 5/13/63 it was noted that subject's father-in-law's car was observed at 2505 Bristol, it having previously been reported that when subject is out of town his father-in-law, ANTONIO MARCHESE, usually spends evenings with his grandchildren at 2505 Bristol.

On 5/15/63, TP 41-C advised subject had not been reported in Tampa, but is reported in Miami and that numbers activity is no longer handled in the Tampa area, with only a few sporadic operators.
